DESCRIPTION: gloves fully impregnated with PVC, with long sleeves. The durable, flexible and soft PVC layer resists abrasion in a dry environment. The model is provided with a sleeve with a length and impregnation of 350 mm, according to the level of protection required for the forearm. Wide cuff for easy removal from the hand. They will not be used in contact with liquids. The level of protection is measured in the palm area of the glove.

FIELD OF USE: gloves for multifunctional handling. The gloves are designed to protect against general handling of materials, for assembly and maintenance, providing protection against slipping,

dirt and moderate mechanical actions. Product suitability must be established for each specific work application as part of the end-user risk assessment program.

WARNING! Gloves should not be used when there is a danger of getting caught in the moving parts of the equipment.

In the case of gloves with multiple layers, the total classification does not necessarily reflect the performance of the outer layer.

Gloves that meet the requirements for puncture resistance may not be suitable for protection against sharp objects such as hypodermic needles.
