INSTRUCTIONS FOR USE

Description: High Visibility Softshell Jacket with detachable hood, Category 2

Code: 9177/9178

Colors: fluorescent yellow (9178) /fluorescent orange (9177)

Scope of use: equipment designed to ensure user visibility in normal environments, without potentially explosive atmosphere, in any light conditions, to be seen by vehicle operators or other mechanized equipment, in daylight and headlights at night, such as: cyclists, ports, airports, railway, parking, road workers, construction sites, warehouses, emergency interventions, etc.

Class 3 – surfaces of fluorescent material and reflective strips (highest class)
- minimum fluorescent material 0,80 sqm / minimum reflective material 0.20 sqm



This garment complies with the relevant health and safety requirements of Regulation (EU) 2016/425 and the above-mentioned standards.

Limits of use: The equipment must be worn closed to ensure the level of protection mentioned above.

Instructions for use and maintenance:

The equipment will be washed inside out to protect reflective and fluorescent strips. During wearing, the equipment must not be covered by any other object or coat. Reflective bands only reflect light. If there's no light, there's no protection.

Storage: The equipment must be kept in cool, dry and dust-free rooms, away from heat sources or direct sunlight. If wet, it will dry at room temperature before storage.

To our knowledge, the equipment does not contain components that can cause allergies, carcinogenic, toxic or mutagenic.

The equipment must be kept clean in order to remain efficient.

Replace the equipment immediately if it is permanently stained or discolored. In the case of a damaged reflective strip, visibility is no longer guaranteed. If the clothing is damaged, it can only be repaired with identical material.

Disposal: Please remove and replace the equipment if it has the following status: A) It is permanently stained or discolored; B) Has damage that cannot be repaired; C) Other conditions that cannot guarantee protection.

Available sizes and choice of size:

Choose the equipment according to the size of the bust/waist (according to the label). This garment has a tolerance designed for comfort and to allow clothing to be worn over the light layers of garments. If the garment layer below is thicker, a larger dimension may be required.

Maintenance icons: Washing to max. 40°C with low centrifugal speed/Do not iron/Do not use bleach/Do not chemically clean/Do not dry in centrifuge.

If the maximum number of cleaning cycles is stated in the care label, it is not the only factor

related to the lifetime of the garment. The lifetime will also depend on usage, care and storage etc.

If the maximum number of cleaning cycles is not stated, material has been tested at least after 5 washes.
